Project Description: The City of Eddyville is requesting GRANT funds to help support a critical wastewater infrastructure project that will replace a failed wastewater treatment plant, enhance wastewater service capacity, improve system reliability, and support significant economic development in the community. This project represents phase 2 of the City's critical response and recovery efforts following the catastrophic failure of its Sequential Batch Reactor (SBR) wastewater treatment plant in January 2025. Key components include a new influent lift station, grit removal and screening systems, a modern case-in-place concrete SBR treatment system designed for longevity and resiliency, a peracetic acid disinfection system to meet current and future disinfection standards, and upgrades to the existing effluent lift station, control systems, and associated buildings.
