Dear Governor Beshear:

Pursuant to KRS 154.12-2035, the Cabinet for Economic Development must report annually on program activity by November 1st of each fiscal year.

The Kentucky Angel Investment Act has a three million dollar per calendar year tax credit limitation. For the fiscal year July 1, 2020 to June 30, 2021, the Kentucky Economic Development Finance Authority approved 91 planned investments with maximum potential angel tax credits of \$1,586,992. The attached report identifies each angel investment project approved by KEDFA during FY 20-21 and the current status of the project as of September 28, 2021.
